



**Intern and Apprentice Tax Credit

- 17) Neither the operations of the Applicant nor the receipt of the requested incentives would violate any existing agreement of Applicant's.
- 18) The Applicant has obtained or is capable of obtaining all necessary federal, state and local permits and licenses for the project that is the subject of the Application.
- 19) The Applicant hereby affirms that it has read and understands the Intern and Apprentice Recruitment Act Program Guidelines.
- 20) The Applicant agrees to give DED, the Missouri Department of Revenue, the Missouri State Auditor, and their authorized representatives, access to any records (electronic and otherwise) of Applicant related to the Application in order to conduct inspections, audits, or other investigations. The Applicant also agrees to give timely and reasonable access to its personnel for the purpose of interview and discussion related to such records.
